This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

1. The Total Maximum Contract Amount is hereby decreased in the amount of \$28,750 for a new Contract Amount of \$329,381 (\$161,355 for FY10 and \$168,026 for FY11). The amount decreased is a consequence of Executive Order 10-04, authorized by RCW 43.88.110. The reduction amount for Employment and Day is based on the FY 2010 County surplus and the removal of FY 2011 State only "Proviso" funding.
2. Paragraph 4. References, sub-paragraph b, is replaced in its entirety with the following:
 - b. WAC 388-850 and 388-845 – 0001,0030,0110, 0205,0210,0215,0220,0600-0610,1200-1210,1400-1410,2100,2110.
3. Paragraph 8 Billing and Payment, sub-paragraph e, is replaced in its entirety with the following:
 - e. Administration: The County will provide program administration and may bill for administrative costs allowed under BARS 568.10. Administrative costs will not exceed 7% of the total County Program Agreement, unless the director of DDD makes an exception under WAC 388-850-045 or the Contractor is exempt per 388-850-040. Monthly claims for administrative costs will be 1/12 of the maximum 7% of the total County Program Agreement budget, unless an exception for a higher percentage is in place.
4. Exhibit A – Budget is hereby replaced with the following Budget Revision:
