PACIFIC COUNTY, WASHINGTON

CRISIS SUPPORT NETWORK

AMENDMENT #1

WHEREAS, the Contract for Services between Pacific County and Crisis Support Network, entered into the 24th of January, 2012, allows for contract modifications; AND

WHEREAS, there is a need to amend sections of the contract to reflect adjustments in the funding available per year of this two year agreement; AND

WHEREAS, there is a need to amend the Use of Funds and Scope of Work to reflect funding being paid to Crisis Support Network on a reimbursement basis for actual expenses rather than a monthly allocation for coordination and administrative duties; AND

WHEREAS, the reporting requirements and allocation of funds designated for Updating the Pacific County Ten Year to End Homelessness needs to be amended to reflect Crisis Support Network being responsible for completing this work in-house rather than subcontracting; AND

WHEREAS, the monthly invoice needs to be amended to reflect these changes;

NOW, THEREFORE, Section 1, "FUNDING", Section 2, Table 1, "USE OF FUNDS AND SCOPE OF WORK", TABLE 1, columns "ACTIVITY" and "ALLOCATION", and Attachment (C), "INVOICE FOR PAYMENT", are hereby amended as follows:

1. **FUNDING**

A total of Fifty Seven Thousand Dollars (\$57,000), \$25,367 for calendar year 2012, and, \$31,633 for calendar year 2013, has been pledged within Pacific County Low Income Assistance Fund No. 127 to provide the RECIPIENT with two years of local matching funds for the consolidated homeless grant provided through the Washington State Department of Commerce. These funds will assist the RECIPIENT with provision of services to low and moderate income housing programs and to implement the Pacific County Ten Year Plan to End Homelessness. Said amount shall constitute the maximum reimbursement the RECIPIENT is eligible to receive from the COUNTY under this CONTRACT. These funds are to be dispersed to the RECIPIENT on a cost reimbursement basis up to the maximum contract amount.


