AMENDMENT #1

WHEREAS, the Contract for Services between Pacific County and Crisis Support Network, entered into the 1st of January, 2014, allows for contract modifications; AND

WHEREAS, there is a need to amend sections of the contract to reflect adjustments in the funding available; AND

WHEREAS, there is a need to amend the amount of funding available for emergency shelter and homeless prevention categories to reflect an increase of \$24,500; AND

WHEREAS, the monthly invoice needs to be amended to reflect these changes;

NOW, THEREFORE, Section 1, "FUNDING", Section 2, Table 1, "USE OF FUNDS AND SCOPE OF WORK", TABLE 1, columns "ALLOCATION", and Attachment (C), "INVOICE FOR PAYMENT", are hereby amended as follows:

1. **FUNDING**

A total of Sixty Seven Thousand Eight Hundred Forty Six Dollars (\$67,846), has been pledged within the Pacific County Low Income Housing Assistance Fund No. 127 to provide the RECIPIENT with local matching funds for the consolidated homeless grant and for other services included within the County's Ten Year Plan to End Homelessness.


