ORDINANCE NO. 134

AN ORDINANCE REPEALING ORDINANCES, SECTIONS OF  
ORDINANCES, REPEALING RESOLUTIONS AND ORDERS

WHEREAS, it has been brought to the attention of the Board of Pacific County Commissioners that in order to complete the codification process, there is a need to repeal certain ordinances, repeal certain sections of ordinances, repeal resolutions adopted as ordinances and repeal orders adopted as ordinances; and,

WHEREAS, the following ordinances, resolutions, orders and amendments have been found to be repetitive of other ordinances, or do not comply with State Law; and,

WHEREAS, sufficient legal notice has been advertised as required by law and all persons present were given an opportunity to express themselves for or against said action; now therefore,

IT IS HEREBY ORDAINED BY THE BOARD OF PACIFIC COUNTY COMMISSIONERS THAT THE FOLLOWING ARE HEREBY REPEALED:

REPEAL Resolution (no number) dated May 18, 1964 establishing a Planning Commission  
This resolution conflicts with Ordinance #88.

REPEAL Ordinance #4, Dated June 3, 1952- Selling of Intoxicating Liquors. State Law  
supersedes.

REPEAL Ordinances #15 and #15A relating to Civil Defense. These ordinances conflict  
with Ordinance #101.

REPEAL Ordinances #23B and #23C Emergency Fireworks Ordinances.

REPEAL Ordinance #29 Driving on Clam Beds.

REPEAL Ordinance (no number) dated May 21, 1951-Driving on Clam Beds.

REPEAL Ordinance (no number) dated August 3, 1953-Driving on Clam Beds.

REPEAL Ordinance #32-Dance Licensing. ORDINANCE #32A TO REMAIN IN FULL  
FORCE AND EFFECT.

REPEAL Order dated March, 1926 dances held in unincorporated areas of Pacific County.  
This order conflicts with Ordinance #32A

REPEAL Ordinance #39 adopting Uniform Fire Code. Uniform Fire Code is contained  
within Ordinance #34C.

REPEAL Ordinance (no number) dated August 2, 1949 pertaining to Produce Vendors. This ordinance in conflict with Ordinance dated August 15, 1949.

REPEAL Ordinance #71-Flood Damage Prevention. This Ordinance was not repealed at the time Ordinance #116A was adopted.

REPEAL Ordinance #96-Vacation of County Roads or Rights of Way.  
ORDINANCE #96A TO REMAIN IN FULL FORCE AND EFFECT.

REPEAL Ordinance #105 pertaining to the regulation of dogs on the Long Beach Peninsula.

REPEAL Section 2 of Ordinance #100 - Food Service Sanitation. This section conflicts with Ordinance #132

REPEAL Sections 1 and 2 of Ordinance #112-Food Protection Rules definitions and general rules. These sections conflict with Ordinance #132.

REPEAL Ordinances (no numbers) dated July 18, 1949 and May 18, 1964 having to do with Flammable Liquids.

REPEAL Order to Sheriff Felber dated November 19, 1959 having to do with use of Courthouse to sell property by others than the Treasurer, Sheriff or Auditor.

REPEAL Resolutions (no numbers) dated June 7, 1937 and September 5, 1945 having to do with games of skill.

REPEAL Order dated March, 1926 relating to operation of pool halls.

REPEAL Resolution #8-dated June 7, 1954 relating to Office of Justice of the Peace.

REPEAL Resolution (no number) dated March 8, 1966 relating to Inferior Court System.
