**ORDINANCE NO. 162B**

**AN ORDINANCE AMENDING  
ORDINANCE 162 SECTION 20 – OYSTERVILLE HISTORIC  
DISTRICT & DESIGN REVIEW BOARD**

**WHEREAS**, the Board of Pacific County Commissioners adopted the Pacific County Comprehensive Plan in August 2010, and subsequently adopted Ordinance 162 Section 20 – Oysterville Historic District and Design Review in December 2012; and

**WHEREAS**, the Pacific County Ordinance 162 Section 20(D) establishes and designates an Oysterville Design Review Board “to review all architectural and historical preservation matters related to physical construction within the boundaries of the Oysterville historic district”; and

**WHEREAS**, RCW 36.70A.020(7) sets the goal that “Applications for . . . local government permits should be processed in a timely and fair manner to ensure predictability.”; and

**WHEREAS**, RCW 64.40.020 gives property owners a cause of action against the County if the County’s land use action is untimely; and

**WHEREAS**, due to the small community and the requirement that every member but one have property interests within the Oysterville Historical District, the application of the Appearance of Fairness Doctrine RCW 42.36.010 calls into question the propriety of the design review process where quasi-judicial decisions are being made by people whose real property values are affected by their decisions; and

**WHEREAS**, through this Amendment to Ordinance 162, Section 20, the Pacific County Board of County Commissioners has elected to contract with a Hearings Examiner; and

**WHEREAS**, the Board of Pacific County Commissioners deems it to be in the public interest to amend Ordinance 162, Section 20 to provide the property owners with an avenue to timely develop and refurbish their properties, while maintaining the historic character of the district.

**IN ACCORDANCE WITH CHAPTER 36.32 RCW, CHAPTER 36.70 RCW, AND CHAPTER 36.70A RCW, IT IS HEREBY ORDAINED BY THE BOARD OF COMMISSIONERS, PACIFIC COUNTY, WASHINGTON, THAT ORDINANCE NO. 162 IS AMENDED BY ORDINANCE NO. 162B AS FOLLOWS:**

Ordinance 162 Section 20(D), (E), (F), (G), (H) (1), and (L) (2): is repealed.

Ordinance 162 Section 20 (I): “ODRB-ACTIONS” is replaced by “OYSTERVILLE DESIGN REVIEW (ODR)-ACTIONS”.

Ordinance 162 Section 20 (K): “It” is replaced with “The Hearings Examiner”.

Ordinance 162 Section 20 (N): “within the jurisdiction of the ODRB” is replaced with “within the Oysterville Historic District”.

Ordinance 162 Section 20 (N) (1): “ODRB” is replaced with “ODR”

All other sections that address the “ODRB” are amended to read the “Hearings Examiner”. The Hearing Examiner will hear all Type III Development Permit Applications per Ordinance 150 – Hearings Examiner and Ordinance 177 - Procedures for Processing Land Use Development Applications.

The sections of Ordinance No. 162 that are not modified by Ordinance No. 162B remain in full force and effect.

If any provision or portions thereof, contained in Ordinance No. 162B is held to be unconstitutional, invalid, or unenforceable, said provisions, or portion(s) thereof, shall be deemed severed and the remainder of the Ordinance shall not be affected and shall remain in full force and effect.

Ordinance No. 162B shall take effect immediately.



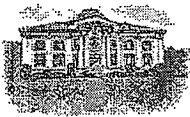

**NORTH WILLAPA BAY SHORELINE EROSION ASSESSMENT  
PACIFIC COUNTY, WA  
WILLAPA EROSION COMMUNITY ACTION NOW (WECAN)**

**Scope of Work and Fee Estimate**

**Background:**

Erosion of the north shoreline of Willapa Bay has been identified to be a threat to critical public infrastructure, properties, coastal wetlands and facilities within the Tokeland and Washaway Beach areas of Pacific County, Washington. Critical areas identified in the April 25, 2016 meeting in Tokeland included the following (referred to as the Project Area):

- Shoalwater Bay Tribe Lands located between Willapa Bay and SR105 west of the gas station.
- Pacific County Drainage District and associated cranberry bogs located north of SR105 and south of Grayland.
- SR105 between Shoalwater Reservation and Washaway Beach.

Previous work within the project area has included the 1998 WSDOT groin/dike located at SR105 and the U.S. Army Corps of Engineers Beach Nourishment on the Shoalwater Bay Reservation. Planning for response to the erosion is being conducted by a consortium of local stakeholders (public agency and private property owners) who are affected by the ongoing erosion and who have organized themselves under Willapa Erosion Community Action Now (WECAN).

**Objective:**

Conduct a pre-feasibility level engineering assessment of the project area utilizing existing data and studies to assist in formulating an understanding of current conditions, develop a range of potential erosion mitigation concepts to protect the identified critical areas, and identify next steps for project planning.

**Scope of Work:**

- Existing Data Review and Compilation. Compile and review existing data and studies from various sources including the Shoalwater Bay Tribe, Pacific County, U.S. Army Corps of Engineers, USGS, WA Department of Ecology, Consultants, WA State Department of Transportation, Pacific County Drainage District, local residents, and other applicable parties for the project area. Summarize existing data and identify new data needs for future phase work.



- Criteria and Basis of Analysis. In coordination with the County and stakeholders, develop a summary of key criteria for use in conducting the assessment. Criteria may include refined geographic limits of critical areas to be protected, acceptance level for protection of those critical areas, and other criteria determined to be important to the assessment work.
- Engineering Assessment. Conduct an engineering assessment of current conditions and a potential range of alternatives to mitigate and reduce erosion to meet the project objectives. The engineering assessment will include the following:
  - *Tidal Channel Migration.* Evaluate changes in conditions from the 1998 WSDOT SR 105 Stabilization project to present time with respect to morphologic changes to the north tidal channel to evaluate channel migration rates and channel stability.
  - *SR105 Groin/Dike Condition.* Utilizing the best available data and review of conditions at low tide, assess current conditions to determine current performance relative to original design and determine extent of maintenance needed and associated benefits to the project goals.
  - *SR105 Bank Stabilization Condition.* Evaluate current condition of stone bank stabilization within the drainage district outlet channel and areas located east of the 1998 SR105 Erosion Stabilization project limits. Determine the need for maintenance, applicability of stone size for the wave environment, and potential risks to the highway.
  - *Shoreline Erosion Assessment.* Evaluate shoreline erosion rates, based on existing studies and available recent data relative to critical zones within the project area and corresponding risks to the project areas.
  - *Erosion Mitigation Concept Development.* Evaluate potential options for mitigating erosion utilizing previously evaluated and completed projects as prototypes for determining applicability to the project area for meeting the objectives. Develop a range of construction cost for the alternatives.
  - *Drainage Ditch.* Conduct assessment and development of concepts to aid in controlling wave action entering the drainage district outlet channel and ditch.
  - *Assessment Summary.* Develop a summary of assessment results with a breakdown relative to each critical zone within the project area.
  - *Next Steps.* Outline the next steps for data collection and engineering analysis to further refine erosion mitigation options.
- Reporting. Develop a presentation summarizing the results of the assessment for use in stakeholder meetings, community involvement, and for meetings with potential funding partners.
- Meetings. Assist the County and partners with organizing and executing stakeholder meetings (a total of two) to be held at the Tribal Center in Tokeland, WA. Prepare presentation for information on project progress and results.



**Budget:**

The estimated not-to-exceed fee for the above described work is \$32,500.

**Schedule:**

Work is anticipated to occur during an approximately 4-month period from notice to proceed.
