

## **NOTICE OF PACIFIC COUNTY PLANNING COMMISSION WORKSHOP AND PUBLIC HEARINGS**

NOTICE IS HEREBY GIVEN that it is the intention of the Pacific County Planning Commission to hold a public workshop at the hour of 4:30 p.m., or as soon thereafter as possible, and three (3) public hearings at the hour of 6:00 p.m. or as soon thereafter as possible, on October 5, 2017 within the Commissioners Meeting Room at the Pacific County Annex Building located at 1216 W. Robert Bush Drive, South Bend, WA.

The public workshop will be to review and discuss The Department of Ecology's recommended and required changes, to provisions of the Shoreline Master Program, consistent with the Shoreline Management Act (RCW 90.58) and the Shoreline Master Program Guidelines (WAC 173-26, Part III).

The first public hearing before the Planning Commission will be to make a recommendation to The Board of County Commissioners regarding recommended and required changes from Department of Ecology pertaining to the Shoreline Master Program Update.

The second matter before the Planning Commission will be to consider and adopt Findings of Fact and Conclusions of Law relating to the August 7, 2017 Planning Commission Public Hearings. All adopted Findings of Fact and Conclusion of Law will be forwarded to the Board of County Commissioners for final consideration.

The last matter before the Planning Commission will be to be to consider and adopt Findings of Fact and Conclusions of Law pertaining to the September 7, 2017 Planning Commission Public Hearing. All adopted Findings of Fact and Conclusion of Law will be forwarded to the Board of County Commissioners for final consideration.
