INSTRUCTIONAL GUIDE FOR RETAIL FIREWORK APPLICATION

Application for a Retail Firework Permit can be submitted to either the South Bend or Long Beach office of Pacific County Department of Community Development each calendar year. Applications that are incomplete will not be accepted. See reverse side for checklist of required items.

SITE PLAN

- A site plan depicting the layout and setup of the sales structure is required. The maximum size allowed for a site plan is 11" x 17". Give plan scale and clearly indicate north arrow.
- Include name of applicant and tax parcel ID number on the site plan.
- Specify what type of structure will be used, including all sizes and dimensions.
- Show location and distance from any existing structures, and public or private access roads.
- Include any specific information pertaining to the site such as, sloping, dirt, grass, gravel or asphalt surfacing, etc.
- Indicate use of adjacent properties, i.e. pasture, woods, vacant lots, commercial, etc.

PERMIT FEES

A retail firework permit fee of \$100.00 shall be paid at the time of application.

PERMIT ISSUANCE

After completion of the approved inspection on July 1st, our Inspector will issue the permit on site.

OPENING INSPECTION

An opening inspection must occur prior to opening for business to the public. Inspections will be before noon on July 1st or the previous business day (Monday-Friday).

OPERATING HOURS

Fireworks can only be sold and purchased between the hours of 12:00 pm (noon) to 11:00 pm on July 1st to July 4th. During this period, fireworks may not be sold between the hours of 11:00 pm and 12:00 pm (noon).

In addition, covered by this application, fireworks may be sold from 12:00 pm (noon) to 11:00 pm on each day from December 29 through December 31, provided an opening inspection prior to December 29 has been approved.
