Every public water recreation facility must obtain an annual license through the Department of Community Development. Renewals are sent out in October and the payment is due by December 31st. A penalty fee will be assessed on January 1st. If payment is not received by February 15th, the establishment will be deemed closed and will require complete re-application as if opening a new facility, including compliance with current codes.

Please be advised that the regulations we inspect under have been revised. Pacific County adopted Board of Health Ordinance No. 7 and Chapters 246-260 Washington Administrative Code (WAC) which apply to all new and existing public pools, spas, wading pools, spray pools and other types of public water recreation facilities.
